

Zevenzicht Nuusbriëf

Die jaar 2017 het baie vinnig ten einde gespoed en almal is alreeds besig met jaareind bedrywighede.

Sekuriteit:

Die aangewese kontrakteur begin eersdaags met die aanbring van kameras in die landgoed en op die grensmure. Tydens die Spesiale Algemene Vergadering het die inwoners versoek dat kameras nie net op die grensmure aangebring word nie maar ook aan die binnekant van Zevenzicht. Die voorlegging met voorgestelde ekstra heffingskoste was op daardie tydstep bereken op R105.00 per maand vir slegs buite kameras. Na onderhandeling met die verskaffer kon ons daarin slaag om nie net die buitemure nie maar ook die binnekant van Zevenzicht onder kameras te plaas teen dieselfde maandelikse ekstra heffingskoste van R105.00 per maand maar nou oor 'n 60 maande periode in stede van 'n 36 maande periode. Ons wag egter nog op die munisipaliteit om sekere krag aansluitings vir ons te maak vanwaar die kameras gevoed moet word. Ons vertrou dat die kameras sal meehelp om ons omgewing veiliger te maak deurdat kwaaddoeners ten minste meer op hulle hoede sal wees om nie deur kameras betrap te word nie en dus ons landgoed liefers vermy.

Die feit dat ons kameras gaan installeer, beteken egter nie dat elke inwoners nie steeds 'n verantwoordelikheid het om sy/haar eiendom so goed moontlik teen misdadige elemente te beskerm nie.

Tydens die Spesiale Algemene Vergadering waartydens daar 'n besluit geneem was oor die aanbring van kameras het meer as een inwoner hulle kommer uitgespreek oor die gebreke by ons ingang. Van die maatreëls en kontroles wat in plek geplaas was, is afstandbeheer meganismes wat aan elke individu uitgereik is teenoor u naam. Daar was ook aan u gekommunikeer dat afstandbeheer knoppies ontkoppel sal word indien daar gevind word dat die knoppies aan enigeen beskikbaar gemaak word. Ongelukkig het dit nou 'n paar keer gebeur dat knoppies aan vriende gegee was om vryelik in die landgoed in en uit te beweeg sonder dat die identiteit van die persone bekend is. Hierdie optrede ondermyn ons sekuriteitspogings en word gesien as sekuriteitsbreuk. Dikwels dra sulke persone ook glad nie

Zevenzicht Newsletter

The year 2017 has almost reached its end and everyone is already busy with year-end activities.

Security:

The appointed contractor is going to start with the installation of cameras on the perimeter walls and on the inside of Zevenzicht very soon. At the Special General Meeting the residents requested that cameras also be installed within Zevenzicht and not just on the perimeter walls. The suggested extra levy was R105.00 at the time of the meeting. After negotiations with the supplier we could keep the extra levy at R105.00 per month for perimeter cameras as well as for additional cameras inside Zevenzicht but now for a 60-month period instead of a 36 month period. We are, however, waiting on the municipality to install certain electrical access points to supply electricity to the cameras. We trust that the cameras will help to make our environment a safer place and to inhibit the activities and plans of perpetrators.

The fact that we install cameras does not take the responsibility away from every resident to accept responsibility for their own property by protecting it against possible criminal elements.

During the Special General Meeting, more than one resident voiced their concerns about weaknesses in the security at our entrance. One of the controls that were put in place was the issuing of remotes against a person's name. It was communicated that remotes will be disabled if it was found that there was misuse and that remotes were made available to other people. Unfortunately, it has happened now that remotes were given to friends to move freely in and out of the estate. Their identity is not known to security or estate management and it undermines our security attempts and is seen as a breach of security. Very often these people are not aware of the rules of the estate either. People are also not aware of the security risk that it is creating for other residents and from a management

kennis van die reëls van die landgoed nie. Mense is ook nie bewus van die sekuriteitsrisiko wat dit skep vir alle inwoners nie.

Wie het uiteindelik afstandbeheer knoppies en wie ry so in en uit by ons hekke? Hierdie vrae kan nie maklik beantwoord word as hierdie praktyk toegelaat word dat knoppies willens en wetens aan enigeen gegee kan word vir gebruik nie. 'n Paar boetes is gevolglik uitgereik om hierdie gedrag aan te spreek en om mense bewus te maak van die verbreking van sekuriteitsmaatreëls van ons kompleks.

Indien u gereëde besoekers ontvang bv. ouers of vriende en hulle wil nie elke keer inteken nie kan hulle aansoek doen vir die gebruiklike permit wat teen hulle voertuig se voorruit vasgeheg word en die hek sal elke keer sonder veel omhaal vir hulle oopgemaak word. Sonder die permit moet hulle egter inteken. Afstandbeheerknoppies word egter net aan inwoners uitgereik.

Ons beplan om op die langer termyn waarskynlik in die volgende finansiële jaar ook metaal skuifhekke by die ingang aan te bring wat oornag toegeskuif word vir groter sekuriteit soos wat baie komplekse vandag alreeds het.

Ander optredes:

Daar was ook in die onlangse verlede opgetree teen inwoners waar die tuin onnet vertoon het ten spyte van waarskuwings en ook die oortreding van bouaangeleenthede. Alhoewel dit baie negatief klink is die doel van die optrede om steeds Zevenzicht te onderhou as 'n rustige en netjiese woonbuurt wat 'n ware tuiste vir al sy inwoners moet bly.

and control perspective it makes it very difficult to handle.

It makes it very difficult to answer questions like who is entering and leaving our estate if many remotes are roaming around between residents and friends and who knows else. A few fines were therefore issued to address this behaviour and to make people aware of their breaching of security measures and rules.

If residents have regular visitors like family or friends then there is the option to apply for a permit which can be displayed on the windscreen of the vehicle. The gate will be opened without the red tape of signing in when such permitted people arrive. Unfortunately, people will have to sign in if they do not have a permit. Remotes are, however, only issued to residents.

Over the longer term, probably in the new financial year, we plan to install metal gates at the entrance that will be closed at night for better security like many complexes are currently doing.

Other actions:

Recently action was also taken against residents with untidy gardens and the transgression of building guidelines after they were warned. Although this may sound very negative the purpose is to maintain Zevenzicht as a peaceful and neat residence that must be a real home to every resident.
